If you're confused by the new CPC program, you're not alone. We created this resource to help you understand how the new requirements will affect you.

# Details on the New CPC Program

The goal of the CPC program is to enhance your professional development. By staying up-to-date on current practice trends, CRNAs will continue to lead the way in delivering high quality patient care.

#### When Does the New CPC Program Start?

- EVEN year cycle starts 8/1/20 \*For the 2020 cycle only, this date has been pushed back to 11/30/20 (due to COVID-19).
- ODD year cycle starts 8/1/21
- If you graduated in or after 2016, then your new cycle will begin 4 years later on the 1st of the month after your initial certification.
- You can begin your recertification application in April in the year you're due to recertify.

#### When Is the 2-Year Check-In?

- EVEN year cycle must check-in 4/22 7/22
- ODD year cycle 2019 must check-in 4/23 7/23
- If you graduated in or after 2016, then your 2-year check-in must be completed no later than 2 years after your initial certification.

	Requirement	Quantity	Frequency
1	Class A Credits	60	Every 4 Years
2	Class B Credits	40	Every 4 Years
3	Core Modules	4	Every 4 Years
4	CPC Assessment	1	Every 8 Years

# Start Here

## **Credits**

#### 60 Class A Credits

CE activities that require an assessment and have prior approval by the AANA:

- Activities include online courses, live meetings, and webinars.
- Assessments include discussion, simulation, case study, self-assessment, or a post-test.
- Authorized vendors will provide AANA prior approval verification.

#### 40 Class B Credits

CE activities that do NOT require an assessment or prior approval by the AANA:

- Activities include precepting students, conducting research, or teaching.
- If you're an AANA member, you can report your Class B credits on their website. If you're not an AANA member, you can report your credits directly to the NBCRNA.
- Class A credits can be applied to your Class B requirement (but not the other way around).

### **CPC Core Modules**


The goal of the CPC Core Modules is to keep your clinical practice up-to-date by providing you with the current evidence-based practice trends.

The Core Modules focus on the four domains of Nurse Anesthesia practice:

- 1 Airway Management
- 2 Applied Clinical Pharmacology
- 3 Physiology and Pathophysiology
- 4 Anesthesia Equipment and Technology

#### **Key Points:**

- The NBCRNA must officially recognize each vendor's modules.
- Starting in 2020 they are mandatory during every 4-year recertification cycle.
- The quality, content, mode of delivery, and cost-per-credit varies from one vendor to the next.
- By completing the CPC Core Modules, you're earning Class A credits at the same time.
- The core modules are NOT intended to be a comprehensive review for the CPC Assessment, but some vendors may also include review material to help you prepare.

# **CPC** Assessment

The CPC Assessment covers the four domains of Nurse Anesthesia practice: airway management, applied clinical pharmacology, physiology & pathophysiology, and anesthesia equipment and technology.

- You'll take the assessment every 8 years.
- You'll have 3 hours to answer 150 test questions.
- The NBCRNA will only allow you to take the CPCA at certain times during the year (2021 testing windows are available in August and November).
- You can either take the CPC Assessment in a testing center or from the comfort of your home with a virtual proctor.

#### What Happens If You Don't Meet the Passing Standard?

CPC Assessment Cycle (2020/21 - 2024/25):

- This exam and future exams serve as a personal assessment.
- Your certification will NOT be affected by your results.
- If you don't meet the passing standard in any of the four domains, you must complete at least 1 Class A Credit in each domain where the passing standard is not met.


